The NC Disability Determination Services is responsible for adjudicating claims filed for disability benefits under Title II (Social Security Disability Income) and Title XVI (Supplemental Security Income) of the Social Security Act for residents of North Carolina. If applicants do not have a treating source (physician, clinic, or hospital), or if the medical reports from treating sources are inadequate or incomplete, then the Disability Determination Services may purchase a consultative examination(s) from other physicians or psychologists.
